

**MINUTES**  
**DETROIT CITY COUNCIL REGULAR MEETING**  
**December 13, 2022**

The Detroit City Council met in, regular session on Tuesday, December 13, 2022 at 6:35 P.M. Mayor Kenny Snodgrass called the meeting to order. Council members in attendance were Terrie Shelby, Shane Cabler, Faye Marshall, and Lori Melton.

There was no one in attendance for public comment.

New business discussed:

- Motion was made by Terrie Shelby and seconded by Lori Melton to appoint Josh Daigle to the vacant council position, effective immediately. Motion carried 4-0
- Motion was made by Shane Cabler and seconded by Josh Daigle to purchase the proposed Mini Excavator and dump trailer as proposed. Motion carried 5-0
- Motion was made by Shane Cabler and seconded by Lori Melton to approve moving forward with the sewer line extension and manhole project at 410 N. and Union. Motion carried 5-0
- Motion was made by Lori Melton and seconded by Terrie Shelby to donate the flagpole from the old City Hall building to the Veteran's Memorial project at the walking track. Motion carried 5-0
- Motion was made to purchase a Kohler 3" water pump and 6.5HP dual tank air compressor for \$1,550.00. Motion carried 5-0
- Structure re-roof at sewer plant – still obtaining bids – FYI only
- Motion was made by Josh Daigle and seconded by Terrie Shelby to concur with the DISD's appointment of Ashley Minter to the Red River County Appraisal District board for an additional term. Motion carried 5-0
- Motion was made by Lori Melton and seconded by Terrie Shelby to increase the tap fees for basic/short taps : water from \$700 to \$950, sewer from \$500 to \$750 \*long taps, road cuts and road bores will be higher based on additional contractor work as needed. Motion carried 5-0
- Motion was made by Lori Melton and seconded by Terrie Shelby to purchase a new desktop computer for C. Arrasmith from Professional Business Systems (\$905) . Motion carried 5-0

Old Business discussed/actioned:

- S. Main St. bridge – T. Nix called the bridge division of TXDOT. They did not have it on their list. They did a preliminary site review in person and deemed that the bridge was not in bad enough shape to be on their replacement list. C. Arrasmith has checked into getting a few boards to do minor repairs.
- S. Main St. project – discussion currently between Charles Edwards, Hayter and City for culverts to be listed in contract as alternates. City or County may be able to get culverts and ditches done before street starts in March/April
- ARP – American Rescue Plan funds \$169,572.26 - lift station pump replacements and parts, line extension and manhole on 410 N at Gandy residence (bid process), N. Main water line replacement (in-house), smoke testing (bid process), bypass installations for San Diego and Deport Street lift stations, bar screen for Deport lift station, city shop repair, purchase mini excavator & trailer
- Sidewalks along 410 N – from Hwy 82 – School – no match from City. Still in process of trimming trees. Work expected to begin mid – end of January.
- Playground equipment has been disassembled and moved from Goodland Boys home to Detroit City Park. Waiting for weather before putting it up.
- Motion was made by Terrie Shelby and seconded by Lori Melton to RATIFY the executive decision made by Mayor Snodgrass on 11/15/2022, to pay employee bonuses of \$1,000 to all employees

Motion was made by Shane Cabler and seconded by Faye Marshall to approve the regular monthly bills along with:

- Pumps & Power - \$4,377.44 – 4" grinder pump and flange adapter for Deport St.
- TCEQ - \$2,278.41 – WW permit FY 2023
- Detroit Auto - \$1,262.63 – tires and mount for backhoe and tractor
- Green Machine Rentals - \$482.00 – trencher to replace line on N. Main
- C&C Rentals - \$95.00 – jackhammer rental for playground equipment move
- Decker repair - \$1,216.20 – bearing repair for backhoe and antifreeze for all
- City Electric - \$1,241.54 – re-wind aerator pump for sewer plant

Motion carried 5-0

After review and corrections noted Motion was made by Faye Marshall and seconded by Josh Daigle to approve the minutes. Motion carried 5-0
