

**MINUTES**  
**DETROIT CITY COUNCIL REGULAR MEETING**  
**July 19, 2022**

The Detroit City Council met in, regular session on Tuesday, July 19, 2022 at 6:32 P.M. Mayor Kenny Snodgrass called the meeting to order. Council members in attendance were Brandon Brown, Terrie Shelby, and Lori Melton.

Michael Davis and Miles Davis were in attendance for comment on an agenda item

Michael Davis & Miles Davis – reopening Union Street between N. Main and 410 N. Plans are to build 1 duplex now and then a second later. There is a water main accessible, but Mr. Davis is requesting an extension of the sewer line that runs along N. Main (not connected to his property). Motion was made by Lori Melton and seconded by Terrie Shelby to open Union to the property from N. Main, but not all the way through to 410. Motion included getting bids from contractors for the sewer line extension as well as from Red River County Pct. 2 for rock to build the street before winter. Motion carried 3-0

New business discussed:

- Consideration on re-opening Union Street from 410 N. to N. Main – see motion above
- Motion was made by Terrie Shelby and seconded by Brandon Brown to Table budgets for WS and GF for July 1, 2022 – June 30, 2022, fiscal year – taxable values and tax revenue information had not been received from Red River County prior to day of meeting. Motion carried 3-0

Old Business discussed/actioned:

- Moving City Hall to Library – City Secretary, T. Nix, has met with local contractor regarding repairs to porch and walkway boards as well as installing overnight, payment drop box. Nix also requested approval for ordering new desks and chairs for office employees. General discussion for condensing books included primary focus to keep all children’s books - offering a \$5 grab bag to public on non-children’s books, with all funds being invested into computer/internet use or copy charge offset for public usage. Motion was made by Lori Melton and seconded by Terrie Shelby to approve all above. Motion carried 3-0

Motion was made by Brandon Brown and seconded by Lori Melton to approve the regular monthly bills along with:

- City Electric – 2” sewer pump & freight for Norris St. lift stations - \$1,591.00
- Freddy Smith – Vac sewer plant (1x), San Diego (3x) - \$3,600.00
- Raulston Electric – lights in council room - \$249.75
- USDA July pmt - \$8,522.95 – brings balance to under \$85,000.00

Motion carried 3-0

After review Motion was made by Terrie Shelby and Seconded by Lori Melton to approve the minutes. Motion carried 3-0

Motion was made by Lori Melton and seconded by Brandon Brown to take actions discussed in executive session – pending legal questions posed in session, to be asked of legal counsel regarding employee performance plan. Motion carried 3-0
