

MINUTES
DETROIT CITY COUNCIL REGULAR MEETING
October 10, 2023

The Detroit City Council met in regular session on Tuesday, October 10, 2023, at 7:03 P.M. Mayor Kenny Snodgrass called the meeting to order. Council members in attendance were Terrie Shelby, Lori Melton, Faye Marshall, Josh Daigle and Tonya Clanton.

New business discussed:

- Loose dogs: Council was advised that Secretary Nix had been in discussions with The City of Clarksville animal shelter to check openings for the 4-5 dogs reportedly running in town. They have not had openings and will call us when they do. The cat rescue has reached out for any available assistance. The request was not on the agenda and was therefore tabled until the next meeting.
- Upcoming community events – Saturday, Halloween movies at the Tabernacle. Trunk or Treat on Oct 28 (3pm – 6pm) and trick or treating to follow. December 8/9th for possible City tree lighting/parade hosted by Detroit United. T. Clanton mentioned ice rink idea from Classic Holiday (done by City of Reno).

Old Business discussed/actioned:

- S. Main Street grant update – TDA CDBG CDV21-0388 –The City is replacing a problematic water line as well as a sewer tap repair.
- ARP – American Rescue Plan Funds – remaining funds of \$56,514.01 must be obligated to a project by 12/31/24 – and projects completed and funded by 12/31/2026. Remaining projects discussed by the Council for ARP funds include, but are not limited to: repairing the City well operating system, possible bar screen installation at Deport Street lift station.
- April 2024 Eclipse – discussion regarding possibly pre-ordering shirts and solar glasses
- Front Street maintenance and repair – TxDOT has been waiting on weather before grinding down the ridges.
- Front Street parking signs & Striping - TxDOT is requesting a letter from the Sherriff's department stating that they will enforce traffic codes per signage.
- Old City Hall – work to begin this week with R. Holdeman overseeing. Motion was made by Josh Daigle and seconded by Terrie Shelby to leave the front of the building the original dark, and paint the other 3 exterior sides to match the natural wood of the new posts. Motion carried 5-0

Motion was made by Terrie Shelby and seconded by Tonya Clanton to approve the regular monthly bills as well as those listed below. Motion carried 5-0

- S&S Welding - \$150.00 for brush rake plate fabrication 4-0 (Terrie Shelby abstained)
