Consistent with the Texas Open Meetings Act, the Council members cannot discuss non agenda items. Speaking times are specific to each speaker and cannot be accumulated, saved or transferred to another speaker.

All speakers are expected to maintain a proper decorum when presenting and while in Council chambers. Threats, personal insults, vulgar or profane language is out of order and may result in removal from the meeting. **All requests for comment must be in writing and turned in to the City Secretary or Presiding officer at least 5 minutes prior to the start of the meeting.**
