DETROIT CITY COUNCIL REGULAR MEETING SEPTEMBER 10, 2024

The Detroit City Council met in regular session on Tuesday, September 10, 2024, at 7:02 P.M. Mayor Kenny Snodgrass called the meeting to order. Council members in attendance were Terrie Shelby, Grace Swain and Tonya Clanton.

Public Comment – No public comment

New business discussed and moved upon:

- Motion was made by Terrie Shelby and seconded by Grace Swain to adopt the proposed property tax rate of 4.99999% per \$100.00 value – motion carried 3-0
- Bank balances were reviewed

 in the top layer of asphalt.
- ARP American Rescue Plan funds \$5,681.82 only project outstanding is City shop door replacement – project estimated for early October
